FIRST ON THE AGENDA

Consolidation: *Draft Charter*

Mr. Chapman thanked everyone for their attendance. He asked that Representative Dickey make any opening remarks prior to opening the floor to discussion.

Representative Dickey stated that he wanted as much feedback and comments as to the proposed consolidation of the two governments. He went on to say that he believed that consolidation could stream line expenses and eliminate redundant services. He also said that he wished to present to the legislature a draft charter that had the consensus of a majority of the people and then give the citizenry the opportunity to vote on the proposed unification of the two governments based on the charter.

Mr. Dickey turned the meeting over to Mrs. Laura Mathis representing the Regional Commission. Mrs. Mathis presented the draft charter (see attachment) to all that were present and gave an overview of the proposed document.

There were many questions, comments and discussion.

At the end of discussion Representative Dickey asked if there was anything in the proposed charter that needed to be changed. There were no immediate comments but members of the audience asked if they could study it more closely and provide comments at a later date.


Representative Dickey provided the members of the audience his e-mail address and encouraged all to provide comments as to the proposed consolidated government charter.

Adjourn:


