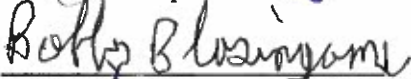
**Adjourn:**

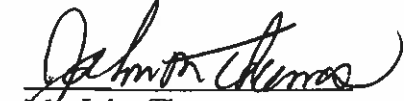

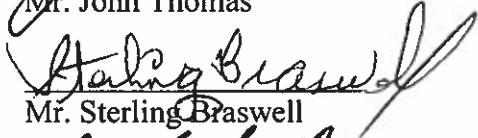

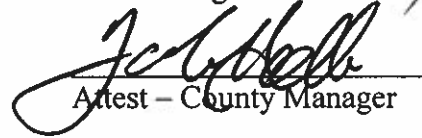
