OLD BUSINESS:

NEW BUSINESS:

Land Water Conservation Grant Resolution for Recreation Department was discussed. Ms. Kimberly Lowe (MGRC) provided a description of the grant requirements, availability, and proposed project details for ball field upgrades. Ms. Lowe explained that it was a \$50K grant request, that Crawford County would be responsible for half that amount, and that the County's portion could be paid out of SPLOST funds already allocated to the Recreation Department. Ms. Sanders confirmed that the Rec Department did indeed have the necessary SPLOST funds to pay. Mr. Spillers made a motion to approve the filing of the grant request through MGRC. Mr. Thomas seconded the motion. Motion carried 4-0.

Ms. Sanders provided the Board with three bids for the purchase of the new mini-excavator for the Water Department. Mr. William Patton explained the differences in equipment and costs of the three bids and recommended the Board approve the Kubota from Mason Tractor for \$37K. Additional questions were asked and answered. Mr. Thomas made a motion to approve the purchase of the Kubota from Mason Tractor for \$37K. Mr. Braswell seconded the motion. Motion carried 4-0.
