WAS CALLED TO ORDER AT 6:00 P.M.**

The following members were present: Mr. Paul Chapman (Chairman), Mr. Bobby Blasingame, (Vice Chair), Mr. John Thomas, Mr. Sterling Braswell, and Mr. Justin Spillers.

**CALL TO ORDER:**

The meeting was called to order at 6:02 p.m. by Mr. Chapman.

**AGENDA APPROVAL**

Mr. Chapman asked for a motion to approve the agenda. Mr. Spillers made the motion to approve the agenda. The motion was seconded by Mr. Braswell. Motion carried 5-0.

**APPROVAL OF MINUTES:**

Mr. Chapman asked for a motion to approve the minutes from the regular scheduled meeting from the 6 November 2018 meeting. Mr. Spillers made the motion to approve. Mr. Blasingame seconded. Motion carried 5-0.

**PUBLIC HEARING:**

**APPEARANCES:**

Ms. Terry Peters appeared before the board requesting the BOC to pave all or parts of Tribble Road and Cummings Lane. There was much discussion regarding the cause of her requests including detours, potholes and dust. Mr. Chapman spoke regarding gaining the rights of way for the adjacent properties. The County manager gave a potential costs for rights of way involving pecan trees which are nearby. Ms. Peters stated she would begin talking to her neighbors and those in the area about providing the BOC with rights of ways.

**ANNOUNCEMENTS:**

County Manager discussed Conference Center Updates, Grass Cutting third time, Run-off elections (early voting, opening all polls, etc.), Photos/videos; County Manager discussed a positive and productive meeting held by the County Extension Agent attended by at least 21 farmers.

**OLD BUSINESS:**

-CCGC Roof Leak Repairs. The County Manager provided the estimates to the BOC. Mr. Spillers discussed structural changes to the building in an effort to eliminate future leaks and costs.

Mr. Spillers made a motion to accept the L.E. Schwartz & Son bid for the roof repairs in the amount of \$16,646.00. Mr. Braswell seconded the motion. Motion carried 5-0.

County Manager recommended a bid by Moisture Control for \$21,000 for specified work. Discussion was had regarding a warranty and Mr. Thomas made a motion to accept the Moisture Control bid, contingent upon a minimum of five year warranty. Mr. Braswell seconded the motion. Motion carried 5-0.

-Title 6 Update for Transit-Language Access Plan and its applicability to Crawford County was discussed. Mr. Spillers made a motion and Mr. Blasingame seconded; the motion carried 5-0.

-CDBG Language Access Plan Update- Ms. Marissa Jackson, the CDBG Grant Administrator, spoke regarding the statutory requirements. She provided a resolution regarding this and Mr. Spillers made a motion to adopt the resolution. Mr. Braswell seconded and the motion carried 5-0. The resolution was signed.

**NEW BUSINESS:**

-E911-Sheriff Walker and his communications Captain provided an in-depth discussion of the need for an E911 system and the quotes for the provision of the equipment and services by 3 vendors. The Sheriff and his team had performed extensive background research. Sheriff recommended one of two quotes by Georgia Two-way, Inc. This is the same company used by Peach County SD. The quotes were for purchase or lease agreements. Much discussion was had by the BOC regarding savings, expenditures and benefits of each. Mr. Spillers and Mr. Chapman recommended the purchase, rather than lease.

Mr. Spillers made a motion for the Georgia Two-way purchase quote. Mr. Thomas seconded and the motion carried 5-0. All in attendance appeared pleased with this outcome.

-Budget Amendments, Shop, Jail; Mr. Spillers made a motion to amend the budget; Mr. Braswell seconded and the motion carried 5-0.

Documents were signed. There being no further business, Mr. Chapman asked for a motion to adjourn the 20 November 2018 regularly scheduled meeting of the Board of Commissioners.






