**FIRST ON THE AGENDA**

**Public Hearing: *FY 2017 General Fund Budget Adoption***

Mr. Chapman asked if there was anyone that would like to be heard in regard to the proposed General Fund Budget for Fiscal Year 2017.

The Board answered various questions presented by the citizenry.

Mr. Chapman made a motion to adopt the General Fund Budget of \$6,999,795. Mr. Braswell made the motion to adopt the budget. Mr. Blasingame seconded and the motion carried 4-0.

**Public Hearing: *FY 2017 Water Enterprise Fund Budget Adoption***

Mr. Chapman asked if there were anyone that would like to be heard in regard to the proposed Water Enterprise Fund Budget for Fiscal Year 2017.

The Board answered various questions presented by the citizenry.

Mr. Chapman made a motion to adopt the Water Enterprise Fund Budget of \$ 358,150. Mr. Blasingame made the motion to adopt the budget. Mr. Braswell seconded and the motion carried 4-0.

**Public Hearing:** *FY 2017 Special Revenue Fund Budget Adoption*

Mr. Chapman asked if there were anyone that would like to be heard in regard to the proposed Special Revenue Fund Budget for Fiscal Year 2017.

The Board answered various questions presented by the citizenry.

Mr. Chapman made a motion to adopt the Special Revenue Fund Budgets as follows:

Mr. Chapman asked for a motion to partially roll back the millage rate for the insurance premium in the unincorporated portion for the County. Mr. Spillers made the motion. Mr. Braswell seconded and the motion carried 4-0.


**Adjourn:**




