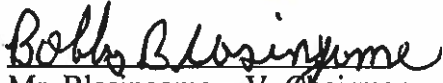
Adjourn:

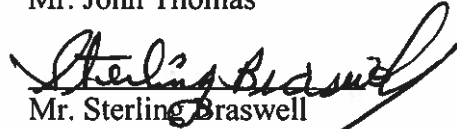
