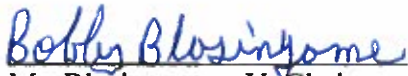
**ADJOURN:**

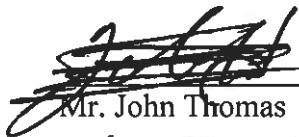

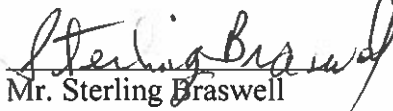
